**From the State College Area:**

1. Via Route 22/322 South to I-81 North
2. Take I-81 North to Exit # 72A
3. Follow steps 5 – 11 below

**From the Allentown Area:**

1. 78 West to I-81 South
2. Via Route I-81 South, exit # 72
3. Turn left onto Mountain Road
4. Follow steps 6 – 11 below

**From the York Area:**

1. Via Route I-83 North – across river
2. Proceed to the I-83/I-81 Junction (81 North). Stay in the right lane
3. Follow steps 4 – 11 below

**From the PA Turnpike (I-76) east or westbound**

1. Take exit 19, take Route I-283 North
2. After 2 miles, follow signs for I-83/I81 North (toward Allentown)
3. Take I-83 North until reaching the split for I-81 (North)
4. Drive approximately 2 miles to the Paxtonia Exit # 72A
5. As you exit, you will be on Mountain Road
6. Get into the left lane and go the next traffic light
7. Turn left at the traffic light onto Allentown Blvd./Route 22 (Toyota dealer on the left)
8. Go to the second traffic light, turn Left onto Shannon Road – Gateway Corporate Center Entrance
9. At stop sign, turn left onto Flank Drive
10. Turn into first parking lot on right
11. The building is a red buff brick, L-shaped, in front of you
12. The main entrance is to the left
